## **1. INTRODUCTION AND BACKGROUND**

The MICT SETA seeks to **hire** a seamless LED display screen for our Annual General Meeting (AGM), scheduled to take place in **Cape Town** on **Friday 27 October 2023**. This is a corporate event attended by our constituent stakeholders in the media and ICT sector and other dignitaries.

The stage dimensions are 6m x 3m. The appointed service provider will be responsible for delivering exceptional services in accordance with the scope of work, ensuring the adherence to the MICT SETA's brand guidelines and image.

## **2. SCOPE OF WORK**

The appointed service provider will be expected to perform the following services as duties and responsibilities:

### **2.1. Seamless LED display screen for stage hire**

- LED Panel Type – Indoor, the service provider will be expected to supply and set-up a seamless LED display screen for indoor as a backdrop for the stage.
- **Size:** 6m x 3m
- The seamless LED display screen must be customisable to meet the MICT SETA branding requirements.
- Pixel Pitch – Optimal resolution. The seamless LED display screen should have an Ultra high contrast ratio, with zero pixelation (no LCD displays). Pixel density for desired viewing distance
- Screen resolution – Full HD 4K for sharp clear visuals. Image quality creating maximum impact for digital content.
- Brightness and contrast – minimum and relevant adaptability for clear visibility in different lighting conditions, ensuring energy efficiency.
- Colour display accuracy and depth showing uniformity of brightness and colour across the screen.
- Panel Technology – ensure seamless integration of LED panels to minimise visible seams between tiles.
- Compatibility with input sources and control systems for easy integration into existing setups

- The service provider must provide support crew during the event and will be required to work with other third-party suppliers.
- Local Footprint (Western Cape) - The service provider should preferably have a branch in Cape Town to optimally service the event in a cost – effective manner.

## EVALUATION CRITERIA

### EVALUATION CRITERIA

MICT SETA complies with the provisions of the Public Finance Management Act, Act No. 1 of 1999 as amended; Treasury Regulations of 2005; the Preferential Procurement Policy Framework Act, Act No. 5 of 2000; Preferential Procurement Regulations of 2022; and the MICT SETA Supply Chain Management (SCM) Policy.

RFQ's received will be evaluated on the following criteria:

#### STAGE 1: MANDATORY CRITERIA

Quotations submitted will be evaluated on mandatory criteria as per below:

- a) Bidder must demonstrate experience in corporate events production.

**Proof of evidence:**

Bidders must submit a detailed company profile highlighting five (05) years of experience in corporate events production.

- b) Bidders must provide project events implemented in the form of a Portfolio of Evidence (POE). Corporate events should include installation of LED Seamless display screens.

**Proof of Evidence:**

Bidder must submit portfolio of evidence for project events implemented in corporate events.

- c) Bidder must have a branch in Cape Town to optimally service the event in a cost – effective manner.

**Proof of evidence:**

Bidders must submit proof of registered Cape Town company address. The following documents will be acceptable as proof of address:

Fully signed Lease Agreement or Utility bill (not older than three (03) months).

**\*\*Bidders that do not meet the above criteria will be eliminated from the further evaluation process.**

## STAGE 2: PRICE AND SPECIFIC GOALS

Only bidders that have met the requirements of the Functionality Criteria will qualify for further evaluation on Price and Specific Goals according to the 80/20 preference point system in terms of the Preferential Procurement Regulations 2022, where 80 points will be for Price and 20 points will be for Specific Goals.

#### 1.2 To be completed by the organ of state

- a) The applicable preference point system for this tender is the **80/20** preference point system.
- b) the **80/20 preference point system** will be applicable in this tender. The lowest/highest acceptable tender will be used to determine the accurate system once tenders are received.

1.3 Points for this tender (even in the case of a tender for income-generating contracts) shall be awarded for:

- (a) Price; and  
(b) Specific Goals.

1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

## 2 DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

## 3 FORMULAE FOR PROCUREMENT OF GOODS AND SERVICES

### 3.1. POINTS AWARDED FOR PRICE

#### 3.1.1 THE 80/20 OR 90/10 PREFERENCE POINT SYSTEMS

A maximum of 80 or 90 points is allocated for price on the following basis:

### 3.2. FORMULAE FOR DISPOSAL OR LEASING OF STATE ASSETS AND INCOME GENERATING PROCUREMENT

#### 3.2.1. POINTS AWARDED FOR PRICE

A maximum of 80 or 90 points is allocated for price on the following basis:

#### 4. POINTS AWARDED FOR SPECIFIC GOALS

4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:

4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—
